New Mexico Youth Soccer Association Board of Directors Meeting 03/06/22 Executive Director Report-Gloria Faber

We are thrilled to be back playing again and are thankful to our member affiliate leagues and clubs that worked tirelessly to get youth players in our communities safely back on the field. It was not easy, and we are extremely grateful for those volunteers that stepped up to make the fall season successful. As is the case across the country, so many players and administrators dropped off or left sports in general due primarily to the pandemic. Our goal this spring will be to reengage players, volunteers, administrators, referees, and coaches and to not only normalize the soccer experiences for participants but to focus on bring our sport back stronger, (more players, coaches, referees and volunteers). The NMYSA staff is looking forward to working with our member affiliates to make that happen. Below is a status of business in the State office and a few new ways we are trying to communicate and listen to our membership.

<u>Compliance</u> – We had several leagues play in the fall without credentialling coaches/players. We however recognize that the primary goal was to get the kids playing and thanks to so many of our affiliates, soccer was played in the fall. For the Spring, we will be working with our members to get coaches/players completely credentialled and to put into place methods to ensure players and coaches are not participating if not registered and eligible to participate.

- SafeSport-Congress passed new laws concerning SafeSport requiring all adult participants be SafeSport trained. This includes our board of directors as well as our affiliate's boards. We are also required to ensure that all players that reach the age of 18 are SafeSport trained and that we offer SafeSport training to parents and youth athletes.
- Risk Management-we will be updating our Risk Management policies to incorporate the new SafeSport requirements which also include limiting one on one contact with adult participants and minor athletes, reinforcement of mandatory reporting requirements among other things.
- We will be going through an insurance audit with our carrier to adjust premiums and review our RM policies.

<u>TOPSoccer</u> – We are happy to be hosting the 2022 West and Mid-West Top Soccer Symposium on April 1-3, 2022, at the Tamaya Resort. NMYSA will pay for any of our affiliate's representatives that want to attend or NMYSA board members. Registration deadline is March 11, 2022.

<u>Grants/Partnerships</u> – We have applied for Grants this season to help with programming below.

- DICKS We received a \$7000 cash Grant and \$1500 in gift certificates.
- DICKS We applied for a \$3800 Grant to pay NovoComm for the BCYSC/NMYSA/YAFL Parent Coalition Website for two years.
- TOPSoccer -We received a grant for \$1100 to purchase jerseys and signage.
- USYS United Cup We have applied and been awarded a \$3000 Grant for NMYSA Cup
 - USYS we have applied for a \$25,000 Organizational Growth Grant to help fund the Las Cruces Middle School League for another year and to start a new initiative that Rick will be coordinating "Intercity League". We should know if we are awarded the Grant this month.



 USSF Innovate to Grow Grant-we have applied for a two-year Grant totaling \$27,000 for referee recruitment and retention. We should know if we are a recipient of ITG in a week or so.

We renewed our partnership with Visit Albuquerque Sports Commission and are still onboarding Trace and have continuing our relationships with Stack, Adidas, Sports Pins, Mojo, Soccer.com and are looking at new partnerships with "Simple Truth" and Game Changer. We are also working with a couple new vendors, Community + for Esports and our new insurance provider, Players Health.

<u>Virtual Outreach</u>- We are trying a couple new methods of outreach with our member Presidents and Registrars and have hosting virtual Town Hall meetings. We received good feedback from attendees and will continue offering these virtual updates. Also, our staff is always available to visit or jump on a call or virtual meetings with our members.

<u>Registrations</u> – Player registrations have exceeded our 21-22 budgeted amount of 15,500. We are now at approximately 16,700 registered players and 2,221 registered coaches and are expecting registrations through the end of the month. We may however loose Lovington Youth Soccer as an affiliate. They typically register 290 players and run a Spring only schedule, but we will continue to work with them towards a continue solution. Thank you to Isidro Castillo for reaching out to the Lovington group. If Lovington does not reform, those players can participate in the Hobbs league.

General – We are wrapping up coaching courses, ODP, Futsal, E-Sports, legislative issues, registrations, compliance reviews, hosted events planning, end of year closeouts/990 return and are now focused on the start of spring season, registrations, MS Soccer, State Cup, NMYSA Cup, member affiliate tournaments, YOP, USSF C License course, USSF D License, AGM planning, budgeting, FWR, vendor contract renewals and planning for next season. We have a lot of work ahead of us with referee programs, rules review/modifications, interstate agreements and laying out the calendar for next season. We are also hoping to re-brand somewhat for next season with new digital assets and a refreshed more modern look. We have received a proposal from Enliven to do so and will continue to negotiate with them for their services.

We want to give our member affiliates a special "shout out" for all they have done to get kids playing soccer this season—thank you! Also, welcome our new board members who are already jumping in and helping with hearings, member engagement and NMYSA programs, (Trey Uriquidez, Heather Starr, Isidro Castillo and Alex Fisher). Thank you to our existing board members for all you continue to do for NMYSA, Pat Switzer, Rennae Ross, Matthew Shappard, Tom Dickerson, Ron Guadette, Jim Cooper, Bill Nordin, Alyssa Nieto, Steve Kinsey and Andrez Montoya. NMYSA would not exist without the contributions of our fabulous volunteer board. Also, thank you to the NMYSA staff who make it a pleasure to come to work each day and who are all committed to the NMYSA mission. Finally, we want to recognize Monty Randolph for his immense contributions to youth soccer. Monty was a selfless person giving his time as a longtime board member of NMYSA, Hobbs President, Referee, Coach, Mentor, Cook and so much more. Rest in peace Monty Randolph-you will be sorely missed by so many in the NM soccer community.

NMYSA Programs Administrator Report March 2022 Board Meeting NMYSA Futsal Series

We hosted a successful first two Futsal events and plan to continue this Futsal Series into this next year as well.

Central Qualifier (Albuquerque, NM December 11th-12th 2021) NMYSA Open Futsal State Cup (Albuquerque, NM February 5th- 6th, 2022)

NMYSA Middle Soccer League (Albuquerque, Las Cruces and more!)

We are excited to continue our partnership with APS/ABC Community School Partnership to host the New Mexico Youth Soccer "Middle School Soccer league". The City of Albuquerque voted to continue to fund this program with a grant. This year we are planning to replace our traditional outdoor soccer league with an Intra School Futsal League. The 29 middle schools will practice and play Futsal or small sided soccer games at their facilities. We will also be providing each school with a full kit including goals, pennies and balls. The Inaugural league for Middle School Soccer in Las Cruces was run in the standard outdoor format and was very successful with the boy's season completed successfully and the first champions being crowned. The girl's season is currently underway, and the championship will be held later this month. Middle school soccer programming is looking to grow, and we are currently in discussions with Santa Fe and Los Alamos to look into starting a middle school league up north. Please let us know if you are interested in Middle School programming in your area!

Referee Shortage and Game Manager Course

We are in the midst of a historical referee shortage and we are working on options to help our local leagues have referee options. For the Spring Season I will be running multiple game manager courses. 1 scheduled course for Gallup, 1 for NWRGSL, 1 for Roswell Youth Soccer and 1 for Deming. As a reminder a game manager can be used in lieu of a referee for game U8 and below. It is a great way to recruit young aspiring referees and continues to be a great method for our leagues that run gaming schedules in the U8 and below division. We will also begin to adopt and beta test a new game manager course that includes training for game managers up to the U12 age group. Please let me know if your organization is interested in a Game Manager Course for Spring 22. Finally, we have applied for a USSF Innovate to Grow Grant that would give us funding for referee recruitment, retention and would help to offset costs for new referees.
