- F. Officer Reports
  - a. President: Dennis,
    - i. St Louis: Jim did a presentation for Far West Regionals in 2009, was great and we lost the bid.
    - ii. Jim: two real issues were the national council passed a new travel policy, much less governance and easier to use. 2. Gloria and Jim got permission to present an open travel policy for Region IV.
    - iii. We learned a lot about how other states are doing things, *i.e.*, Kohl's American Cup.
    - iv. Risk Management was a big educational item, as well as paperless systems. RM is not fool proof. We do more than most State Associations. A matter of time before we will all be communicating electronically. On Oct first ETravel will be ready; we will not be able to unveil at AGM.
    - v. Josh attended meeting with development issues and player development, best practices for Coaches who teach soccer given out to all candidates who attend D license course.
    - vi. Region II coaching committee came up with Total player development; Josh has requested an electronic copy so that he can email them out.

- vii. Region IV coaches feel like they don't have a lot of input with the Associations and will come up with a Region IV committee to discuss coaching education, etc.
- viii. No information on new requirements for D license
- b. Vice-President: Coach's Report Josh
  - i. YOP: we have 85 players; today's session kicks off around 10:00
- c. Financial Officer (w/ Budget Committee report) Tom
  - i. Balance sheet and Profit and Loss statements presented; Balance sheet looks good and we may be in the black because of the increased registration.
  - ii. We have an accountant who does our tax forms and we have an audit that was performed two years ago and do audits at the end of a president's term
  - iii. Gary and Tom are looking at an internal audit
- G. Director of Cups and Games Jim
  - a. Appointment: We need to approve Ron, Dennis has appointed Ron and we need to ratify the appointment. Motion by Tom to ratify Ron as Director of Cups and Games; second by Mark P. Motion carried
  - b. Ron would like 3v3 tournaments every month and would like to have national 3v3 tournament in NM
  - c. State Cup Update Jim has the schedule and will publish tomorrow afternoon; need a brief state cup meeting after this meeting -- very short. Put schedules out to coaches and received one legitimate request for change, got some feed back on the criteria for scheduling and was well received. When someone asks for an email please make sure you have the right email address; several email addresses were not correct and communications where not received. Managers were emailed about the schedule and coaches did not get correspondence.
  - d. Kohl's American Cup Jim only 8 or 9 applications at this point, Durango Cup is same weekend, email blast to the state, we need to decide how we do Kohl's. Most of America not playing American Cup in the same format that they play the rest of the schedule.
- H. Registrar's Report Gloria
  - a. We could have at least another 100 or 200 registered, we are at 19,009 currently. Increase in a lot of our smaller leagues with growth, some of the districts are growing.
  - b. On-line registration and new ETravel: No longer require that players sign the back of the card; only for Regionals and Nationals. US Club Soccer is our competition and with the changes, we can make it easier for us for travel and register players. We need to define our requirements and then make our rules to meet these requirements. Region IV is way behind in automating as compared to the other Regions.
- I. Committee Reports
  - a. Rules John Danzeiser, Gloria, Dulcie General Rules and Procedures Manual will be posted on line for review and we could choose to vote on this at our April Board Meeting if we wish.
  - b. Referee Assault issue: there is a referee abuse rule versus referee assault. Federation rule doesn't use the word Parent, NMYSA using the word parent for abuse not for assault. Make definition of Referee Assault and Abuse the same.
  - c. Travel and Risk Management will be our focus as we finish on the General Rules and Procedures Manual.
  - d. Risk Management manual
    - i. Five pages of Risk Management that we know have changed are in the package, will be posted and will be voted on at the April Board Meeting.

- ii. Oregon table on Criminal Convictions and a NMYSA criminal conviction matrix draft copy. Discussion on what a felony is, assaults, etc. RM will have some black-and-white rules for some criminal arrests/conviction and some guidance on the other such as Felony, Misdemeanors etc.
- iii. We will do backgrounds checks on AYSO teams and others outside the leagues upon request of the league.
