- ii. Josh was also in Pittsburgh, for full details see TD Report below are the highlights
  - 1. Continue to work on comprehensive Player Development Curriculum, have draft copy if anyone would like to see it, when finished NMYSA should distribute to all clubs/leagues in state
  - 2. US Youth Soccer has released new coaching DVD 'Skills School'.
  - 3. US Youth Soccer is developing National Coaching Staff to teach NYL courses across the country
  - 4. Montana has proposed a US Youth Soccer lower tier Regional championship competition, which would include smaller states that go to FWRs and don't advance. Region IV is looking into the idea.
  - 5. US Soccer is working on some minor changes to the new "D" Curriculum based on feedback from TDs. Josh is working with US Soccer to allow senior member of our State Instructional staff to apprentice the new "C"-license course at a national coaching school. Josh can now teach the National "C" course.
- iii. Coaching Education Update, in the past month we have run a successful "D"-license course (28 candidates) in Albuquerque and a Youth Module 1 in Deming, courses in Farmington, Gallup and Roswell are scheduled for the next month and a "D" course in the south-east of the state is on the books.
- iv. NMYSA Coaches Association Update: due to declining registration numbers and the potential for better communication thru the new web site, we will no longer accept new members to the association and will be phasing it out as current memberships expire. This will be replaced with a segment on the new website which will contain lesson plans and coaching articles at no charge.
- v. ODP report: NM ODP sent seven teams to 2008 ODP Regional Championships in Phoenix AZ, the 93B and 94G advanced to their semifinal and the 91B lost on kicks from the mark in the final. Congratulations to 6 of our ODP players who have been invited to travel with their Regional teams to international destinations: Michael Ambrose, Kevin Schafer, Jacob Nevarez, Dennis Sanchez, Pat Pacheco and Devon Sandoval.
- vi. Does the state have record of coaches and what course they have completed? 2005 and forward we have the documentation.
- c. Coach's Report: See handout that Josh gave us on NMYSA Coaching Education Program Strategic Plan and give feedback
- d. Financial Officer (w/ Budget Committee report): Tom D handed out a sheet that have forecast column against actual YTD, so far so good

### H. Committee Reports

- a. Rules Risk Management Table/Travel documents
  - i. Motion by Eric, to make this statement part of 6.02.05 and add as Appendix A.5 as a quantitative mechanism whereby NMYSA decides on individual's eligibility to be issued a Risk Management Clearance, 2<sup>nd</sup> by Sonya. Individuals with a pint total of 10 or greater shall be automatically disqualified based on information obtained from the mandatory background check. Discussion: they can always ask for an AP meeting to explain the points, etc. Want to make clear it could be one conviction or a multiple convictions -- it is an accrual point

- system. Motion pulled and restated by Eric: To add the Risk Management Table as Appendix A.5 in the Risk Management Manual, and to add this statement as a bullet to 6.02.05 of the Risk Management Manual: "Appendix A.5 is a quantitative mechanism whereby NMYSA decides an individual's eligibility to be given a risk management clearance. Individuals with a point total of 10 or greater shall be automatically disqualified based on information obtained from the mandatory background check." This applies for one conviction or multiple convictions if the points add up. Motion seconded by Sonya. Motion PASSED
- ii. Travel and Tournament Manual. Motion by Tom, seconded by Mark to insert the words current version between the and United in the Introduction 4.00 of the manual. Discussion. Line three will read "The current version of the US Youth Soccer Travel Procedures are included in full as Section 4.01." Motion Passed.
- iii. Travel and Tournament Manual.
  - 1. Motion by Tom seconded by Sonya, to make the following change: Section 4.02.01.02 change from "An NMYSA Permission to Travel Certificate is required for any travel. Travel is defined as participation in any tournament within or outside of New Mexico, or friendlies or scrimmages against non-NMYSA teams." To "An NMYSA Permission to Travel certificate is required for any travel. Travel is defined as participation by a coach or team in an event, which is conducted outside the State Association in which the player, coach or team is registered." Motion passed.
  - 2. Motion by Tom seconded by Sonya to make the following change: To change section 4.02.02 from "4.02.02 Travel to Instate Tournaments. The requirements for sanctioned travel described in 4.01 also apply to New Mexico teams participation in New Mexico tournaments. E-Travel permission must be obtained for any tournament as described above, and for any scrimmages or friendlies involving any team not registered with NMYSA." To "4.02.02 Travel to Instate Tournaments, Friendlies or Scrimmages. NMYSA registered teams may participate in New Mexico tournaments, scrimmages or friendlies without notice, so long as the players and coaches are registered for the current seasonal year and are in good standing. In order to participate in these events, the team coach must have an official NMYSA roster, individual player/coach pass cards, original NMYS Membership forms, (with medical release information for each player), and the individual proof of age documents as outlined in rule 204 of US Youth Soccer Policy manual. Motion passed

  - 1. APM got ideas and we how have a VISION, MISSION and CORE VALUES.
  - 2. We have a draft of long range plans
  - 3. Good things will happen with us getting the FWR 2010 Bid the synergy will now be part of the Global Strategy
  - 4. Jim gave presentation and gave hand outs and now the BOARD needs to come up with PRIORITEIS.
  - 5. Struggling with referee program, NMYSA is charged with REFEREE EDUCATION.

  - i. We have a plan on how and when the NL was going to be published. Now we are going to an on-line version and now people don't think we have deadlines, until we have enough discipline to go to an on-line NL at this time. The printed NL has a deadline and there is a table that tells us what needs to get out and why it needs to go out. January's newsletter is not out yet. I now

The deadline for the next publication is March 1 and the last NL is not out.
