    - ii. Ran the following coaching classes: "E"-license in Farmington, Youth Module in Gallup, 2 very successful Youth Module classes in Roswell and Youth Module in Taos

Would like to have coach education coordinator for each league with a Regional coordinator scheduling the classes; discussed making the coaching education mandatory for all coaches at each level. Also getting coaches trained to teach the coaches at all levels. We should have 40 + classes each year from the state; currently NWRG and Farmington are taking full benefits of the classes. Because the classes are free coaches tend to sign up and not show up.
