1. Officer Reports

Presidents Report - Salt Lake City USYS Region IV Workshop

The Presidents in USYS Region IV discussed the causes and amount of concussions in youth soccer.

- USYS conducting a study and may recommend eliminating headers for an age limit cutoff.
- Other causes of concussions will be included in study.
- Head gear does not appear to have any relative impact on concussions.

Vice Presidents Report - Salt Lake City USYS Region IV Workshop

- The operation of Region IV will move under USYS for all aspects except policy making decisions.
- Region IV last year was in charge of player selection for ODP.
- Region IV ODP lost \$140k last year.

Technical Director Report – Salt Lake City USYS Region IV Workshop

The Technical Directors discussed various concerns and changes to coach licensing.

- Use the e-platform (online) to provide additional coaching material, instructional video, etc.
- The online delivery of the D, E and F-Licensing material would be easier for the administrators.
- The USYS F-License will be brought back with appropriate age grouping as follows; U5-8 F-License, U9-12 E-License, U12-14 D-License.
- The F-License is very similar to the NMYSA Youth Module 1 and would it cause the Youth Module 1 to be phased out.
- Will it be a pre-requisite for the E-License and is it mandatory?

ODP Director Report - Salt Lake City USYS Region IV Workshop

The ODP Directors discussed the future for ODP, is it beneficial?

- Is there value in the ODP Regional Camp?
- There were issues at the regional camp involving one player from New Mexico stealing money. He was permanently suspended from the program.
- The Regional ODP Championships is still a worthwhile endeavor. A great opportunity to showcase top players from each state.
- The Region IV state associations need to be more involved in player identification.
- ODP Regional Championships for 2014 moved back to Phoenix from Las Vegas.
- ODP Training and Identification under way.
