Soccer Complex in Bernalillo: The Tamaya Development Corp. will be the new oversight group as the pueblo has nullified the lease with SWYSC. Contracts are in negotiations with DCSL/ASL and others wishing to use fields.

Referee Innovate to Grow Grant will help local referees with registration and kits.

TV adds during World Cup appear to be a good investment.

Local leagues can use NMYSA and USYS logos.

NMYSA can take the panna cage to local areas to help promote local soccer events.

• State Cup/NM Cup Committee:

NCS rule changes: first roster freeze is State Cup. League play requirements modified, and transfer rule restrictions removed. Roster continuity is 50% at every stage after SC.

Rules Committee:

Need to update the Risk Management matrix.

• Referee Report:

Referee retentions is low. Las Cruces has a 3-year program to recruit, educate and retain referees.

There are 288 referees in the state, 274 are grassroots referees. (6 mentors, 1 referee coach).

A risk management misconduct hearing is in the works.

Discussion about making a new program, NMYSA Bucks, where local leagues could apply for up to \$1,000 per season.

Tom Dickerson moved to use tournament sanctioning fees and some grant money as approved by the BoD to allow local leagues or clubs to apply for grants up to \$1,000 for hardships and/or growing of the game such as equipment. The grants will be awarded by a committee of at least three (3) board members. This grant will be named NMYSA Bucks. Second by Isidro Castro. Passed
